

## KinderPrep – 12<sup>th</sup> Grade Continuous Enrollment Contract

At New Life Christian School, we view each stage of education with the end goal in mind. From the time your students enroll at NLCS, they are being equipped to be graduates who are Imitators of Christ, People of Virtue, Lovers of Beauty, Discerning Thinkers, and Articulate Communicators. You have decided to partner with us in education, and we value that partnership. Continuous enrollment allows you to initially enroll your students in NLCS, and they will remain enrolled until graduation. <u>Once you sign the Continuous Enrollment Contract, your student will be continuously enrolled until graduation or until you notify NLCS in writing of withdrawal.</u>

The Board desires to plan and develop budgets according to the projected enrollment. We aim to continue to grow and improve our programs and build on the solid foundation of classical Christian education developed over the past few years.

Beginning with the 2023-2024 school year:

- I agree that the terms of my student's continuous enrollment begin with this signed contract and, therefore, continue automatically through the completion of grade 12, or if necessary, until New Life Christian School receives written notice of withdrawal.
- I understand that if my student is NOT planning to return or intends to move from full-time to part-time, I must notify the Business Office in writing by March 29.
  - Withdrawal notices received after March 29 and before April 30 incur a \$600 penalty per student.
  - Withdrawal notices received between May 1 and May 31 will incur a \$1,200 penalty per student.
  - Withdrawal notices received after May 31 require payment for the next academic year's tuition in full.
  - In the event of withdrawals due to job relocation that requires moving from the area, chronic student illness, unexpected loss of family income, or similar hardships, the Board of Directions may make an exception.
- For the enrollment in the 2024-2025 school year, the enrollment fee schedule is below and is payable by March 29, 2024. There will not be a re-enrollment fee in future years.
  - \$200 per student entering 9<sup>th</sup> to 12<sup>th</sup> grade, increasing to \$300 if received after March 29.
  - \$150 per student entering KinderPrep to 8<sup>th</sup> grade, increasing to \$225 if received after March 29.
- If my student(s) is asked to leave or is expelled from New Life Christian School, tuition is payable for the entirety of the school year.
- The parent or legal guardian is agreeing to pay tuition to New Life Christian School as published annually. A fee of 5% per month will be assessed on accounts that are 90 days or more past due and will be assessed on the full balance until the balance is paid in full. One of the following plans must be selected. A payment plan may be changed by providing written notification to the Business Office with 30 days' notice.
  - Single Payment:
    - Tuition paid in full by June 30 will receive a 3% discount.
    - Tuition paid in full by July 30 will receive a 2% discount.
    - Tuition paid in full by August 23 will receive a 1% discount.
  - Semi-Annual Payment Plan:
    - Tuition paid semi-annually receives a 0.5% discount. Payments are due by August 5 and January 6.
  - $\circ$  Monthly payments with automatic bank drafts on the 5<sup>th</sup> or 20<sup>th</sup> of each month.

I understand that thirty (30) days' notice, in writing, to New Life Christian School is required if I change banks and/or accounts.

• I understand that students with canceled enrollment and with accounts in good financial standing may re-enroll if space is available, but the cancellation is nonrefundable.
